KODIAK COMMERCIAL SALMON FISHERY ADVISORY ANNOUNCEMENT # 13 For Emergency Order #4-FS-K-13-26

There will be a **72-hour extension** to the current commercial salmon fishing period from **9:00 p.m. Friday, July 3 to 9:00 p.m. Monday, July 6** in the **Outer Ayakulik Section** of the **Southwest Kodiak District**.

There will be a **57-hour** commercial salmon fishing period from **noon Monday, July 6 to 9:00 p.m. Wednesday, July 8** in the following areas:

- The **Northwest Kodiak District**;
- The **Northeast Kodiak District** (except the Buskin River Section will remain closed);
- The **Eastside Kodiak District**;
- The **Afognak District** (except the Duck Bay, Izhut Bay, Inner Kitoi Bay and Outer Kitoi Bay sections remain closed); and
- The **Mainland District**.

The **Foul Bay Special Harvest Area** **will close** to commercial salmon fishing at **9:00 p.m. Wednesday, July 8**.

Fishermen are reminded that in the **Kodiak Area (including the Mainland District)** until further notice, **Chinook (king) salmon 28 inches or greater in length may not be retained by purse seine gear** in the commercial fishery and must be returned to the water unharmed.

Closed Water Adjustments:

Closed waters for Saltery Creek (stream # 259-415) are normal closed waters as described in regulation from **noon Monday, July 6 to 9:00 p.m. Wednesday, July 8**.

Closed waters are reduced in **Foul Bay** to the stream terminus at Hidden Lake Creek (stream #251-406) until **9:00 p.m. Wednesday, July 8**.

Concerning the North Shelikof Strait Fishery:

Short notice, inperiod closures may occur for seine fisheries in the Seaward Zones of the North Shelikof Strait area (**including the Cape Igvak Section**), as designated in the North Shelikof Strait Sockeye Salmon Management Plan (5 AAC 18.363). Closure announcements may occur at 8:30 a.m., 10:00 a.m., noon, 2:00 p.m., 5:00 p.m., or 8:00 p.m. on VHF channel 6.

As Previously Announced:

The following areas remain **open until further notice:**

- The **Spiridon Bay Special Harvest Area** (Telrod Cove).

Other closed waters are as shown on the Kodiak Area Salmon Statistical Chart and detailed in the Commercial Salmon Fishing Regulations (5AAC 18.350). Statistical Charts, Harvest Strategies, and Commercial Salmon Fishing Regulations are available at the Kodiak Fish and Game office.
